
**Campaign Loan Agreement**

I, **Jesse Bailes**, hereby loan the sum of **\$5,000.00** to the **Jess Bailes for Magistrate Committee**.


Jess Bailes for Magistrate Committee agrees to repay Jesse Bailes the principal amount of \$5,000.00 together with simple interest at the rate of 1%.
