State Treasurer Moore wished to thank the Commission for letting him attend the Commission meeting for the presentation. This money is from the firearms auction, in which all proceeds go back to the police department that turned the guns in. State Treasurer Moore stated he had two checks to present, one to South Charleston PD for \$11,193.75 and one to the Kanawha County Sherriff Office for \$16,087.50. Sheriff Rutherford stated this money would go back into training and equipment, which is a great program that keeps the guns off the street.

Kim Fleck informed the Commission that these are non-tax sources like the ARP account, Financial Stabilization, and Rainey Day. The total is over \$50M. Commissioner Wheeler moved to approve the F.Y. 2023-2024 Special Funds budgets in the aggregate amount of \$50,020,159. Commissioner Salango seconded. Motion carried.

Discussion regarding Security Plan for the judicial building Commission President Kent Carper Commissioner Ben Salango Commissioner Lance Wheeler

Chief Crawford stated over the past 10 months the Sheriff Office has been working on a plan in progress, and we have an approximate estimate. We consulted with the Circuit Judges, Family Court Judges, and Magistrate. The proposal is \$310,000, and one part is the front part of the building to strengthen the security where people enter. Commissioner Wheeler asked if these were the recommendations from the Sheriff. Sheriff Rutherford stated yes, we have checked the entire building and made this recommendation, however, the plans may change once we start, but not too drastic of a change. Chief Crawford stated they want to make these changes as quickly as possible to not interrupt the Judges & court hearings. Commissioner Wheeler stated that each year an application for the Courthouse Security Grant is submitted, can we put this in? Sheriff Rutherford stated we normally don't get that much. Commissioner Salango asked if this includes an upgrade for Family Court Judge's parking. Chief Crawford stated yes it has been looked at. Recommendation is to have an engineer look at it and see what is feasible and what is not. Commissioner Salango asked if the Commission needs to engage an engineer or is the Sheriff's Office going to. Sheriff Rutherford stated that the Commission would need to do it since it's the Commission's building. Commissioner Salango stated that some of the security upgrades cannot be made public due to securing the safety of the building. Commissioner Salango asked that staff follow up on getting an architect and engineer involved regarding the plans, including the Family Court parking.

Sheriff Rutherford stated that this started when the State first came into existence. The Sheriff is responsible for collecting 80% of the taxes before he gets this \$15,000 commission. This is not extra money, and it is in the Sheriff's salary. Commissioner Wheeler stated that the Commission fought to get the Legislature to take this requirement away.

Allen Bleigh informed the Commission that he met with Commissioner Carper, Chris Settles, and Beth Thompson a week ago to explain HB 2526. It will permit people to get a refund of their personal property tax, but it is not effective until Jan 2024 with a refund coming in 2025. They will tell people not to pay for their property in full during the first half. You will only get a tax credit if they pay 1st half and 2<sup>nd</sup> half on time. Commissioner Salango stated that if you do not pay your full year of taxes during the first half a person will get a credit once they pay the 2<sup>nd</sup> half on time. Allen Bleigh stated that is correct. Mr. Bleigh added that they do not get a check; it's a credit on their state taxes. Normally during our 1<sup>st</sup> quarter, we collect 60% of our revenue, which is the concern.

Teresa A. Ansell, President & Chairman of the Board

Teresa Ansell informed the Commission that they inherited the playground and have 275 homes in our community. It was built in the 50's, and then in the 80's a Stonewall football player that went to the NFL built some wooden structures, which are now rotting. We developed a non-profit to take over the playground, and we do fundraise and have liability insurance, which is \$1,200, but does not cover damage to the property. Commissioner Salango asked how much they have raised and what they need. Ms. Ansell stated they have raised approximately \$30,000, and our lowest long-term program option is \$100,000. We are looking for grants. Commissioner Wheeler stated that he had never seen a playground made out of wood.

So far, we have brought in \$18,797. Steve Neddo stated it has been very successful and makes it easier to get homes demolished. Commissioner Wheeler stated that we give homeowners time to fix their homes if they desire. Commissioner Salango stated this is a public safety issue and this is a great program, and our Planning Department gets so many calls on abandoned properties.

Marc Slotnick informed the Commission that this is for the tax years 2021 & 22. The Assessor objects based on failure to file an appropriate personal tax return. Steve Duffield stated that the taxpayer failed to file a return in time. If the taxpayer doesn't file this by late September, the Assessor does not have any way of knowing, and we use an estimate based on the prior year's returns. The owner, Steven Hall agreed that the papers were filed late; however, they were moving and did not file a return. Mr. Hall stated they have 40-year-old equipment that's being assessed as new. Mr. Hall stated that they are fine with paying the penalty but not increasing the value of the tax appraisal. This was \$9,000 extra in taxes. Marc Slotnick stated that the law is 11-3-27; if a clerical error or a mistake is made unintentionally, the Commission can change it. Commissioner Wheeler asked what the law says about the taxpayer filing the forms. Marc Slotnick stated it is on the taxpayer. Mr. Hall admits it was his fault for not filing; my disagreement is the increase in assessment. The Prosecuting Attorney informed the Commission that the Assessor's Office states they calculated as the law requires as they do every business. Mr. Hall said
