Discussion regarding the emergency weather event that occurred on April 2, 2024, to include but not be limited to, response by emergency agencies and damage assessments throughout the County

Commission President Lance Wheeler Commissioner Ben Salango Commissioner W. Kent Carper Jennifer Herrald, County Manager CW Sigman, Emergency Management Director David Workman, Planning Director

CW Sigman informed the Commission that they had a wonderful team throughout multiple agencies including State of ER Management, Metro, Commission staff, KCEAA, Sheriff's Office, Red Cross, City of Charleston, Planning, and our responders. Citizens reacted to the warnings. Commissioner Wheeler said it was a well-oiled machine and it was due to the hard work of everyone. Commissioner Salango said this was a storm that came on a sunny day, Capital Stret was packed with people walking and that's when the sirens went off. People heard them and took shelter. CW Sigman said that AEP is answering every question to the best of their ability. Commissioner Carper asked staff to send a letter to AEP commending them for their response. Jennifer Herrald said that the Planning Department and ER Management with assistance from KCEAA are doing the 123 assessments door to door. They are giving sheets of paper with information to residents who still don't have power. We advertised the number to the Planning office to report the damage. We have received a very low number of calls, 23, but again people's power is still out, and some may not know to call yet. That is why we are going to every community. A lot of damage was due to downed trees, this is different from floods, most insurance will cover the damage. Shawnee suffered some severe damage since the storm went right through the Institute area. So far about \$60,000 in emergency orders to get work completed at Shawnee. Tree removal, turf repairs, fence repairs, goals repairs, and debris removal. Commissioner Salango said that Shawnee had a really good group of volunteers to help. Jennifer Herrald said that the county's insurance company was there that afternoon to look over the damage. We are doing everything for the tournament this weekend. We need to look at the Courthouse roof which may have received some damage. Mike Moles said the will need to bring the crane back in to look it over.

Commissioner Carper declared that the crane was an emergency and to proceed as soon as possible. Commissioner Salango seconded. Motion carried.

Jennifer Herrald said the KCEAA had some damage to their tower, and they were fixed yesterday evening. Monica Mason said that they were very fortunate across the county and our facilities. Jennifer Herrald said that the Quick Community Center has some trees that were down that are not blocking anything or causing an emergency situation. Mr. Workman has this on the list to have the tree removed. The Cleanup is this weekend in Sissonville, and we have arranged for extra deputies for traffic control. Planning is going to be quite busy.

Update regarding Region III Workforce Development Board of Kanawha County

Commissioner W. Kent Carper Commission President Lance Wheeler Commissioner Ben Salango Andy Richardson, Acting Director

Andy Richardson provided the Commission with a report and wished to give an update. Mr. Richardson said it was about a year ago that the Commission persuaded him to come onto this board. There was bad will on the board and with the Federal Government and things were a mess. Mr. Richardson came here and shared his vision and four goals, and those four goals have been achieved and they are moving forward into a new phase. In December the Board asked Mr. Richardson to run this until June 2026. Mr. Richardson just wanted to come back to give a brief report at the beginning of his tenure. Since August they completed three financial audits and the most recent was a clean audit. A successful story they've had is a veteran who didn't want to apply for unemployment because he saw it as welfare, and he was living in his van. They got him engaged with the veterans' services, into the shelter, and enrolled in unemployment. This man's life was saved by his team. Commissioner Carper said that he believes Andy has done a wonderful job. Commissioner Carper said that Chris Settles has spent more time on this project than he could ever have imagined. The Governor's office was ready to shut this program down. Now it is functioning quite well and one the State will look at to have others emulate said Commissioner Carper. Commissioner Salango said that it is a night and day difference, and we are truly thankful. Commissioner Wheeler said that he was told that Mr. Richardson is working with Day Court and Drug Court and anything they can do to help this program is appreciated

Discussion regarding letter from West Virginia American Water Company rescinding their offer to purchase Sissonville PSD and all matters related thereto

Commissioner Ben Salango Commission President Lance Wheeler Commissioner W. Kent Carper Brooks Crislip, Director of Business Development, WVAW Pat Taylor, Board Member, Sissonville PSD

Commissioner Salango thanked everyone for coming and he asked this to be placed on the agenda to clear up any confusion as to why the water company pulled the Sissonville PSD offer. Brooks Crislip said that the first financial decision was to purchase Union and then Commissioner Carper suggested looking at Sissonville PSD and they were tied together financially. When Union was removed that made it unattainable for Sissonville by itself. Mr. Crislip said that the Sissonville PSD needs about \$20M in improvements and without the Union customers WVAWC cannot justify the expense. Commissioner Carper said that the UPSD knew they would kill the deal for Sissonville by declining the purchase. Commissioner

Salango said that he understood they were tied together but he had hoped the water company would still move forward with Sissonville. Commissioner Salango said that he just wanted general information for the public, so they knew what was occurring. Brooks Crislip said they would like to apologize to the Sissonville PSD and they are disappointed they cannot move forward. The challenge is the amount of money needed just for the improvements. Commissioner Carper asked if the water company would look it over again. Brooks Crislip said they could look it over. Pat Taylor said he has been chair since February and he is a short-timer on this board, they had this on their next agenda to vote on taking the offer. Commissioner Carper asked if he would state how he was going to vote. Pat Taylor said no. Commissioner Salango said they may have objected anyway. Pat Taylor said possibly. Commissioner Salango said that the Sissonville PSD has an ARP application and how are they going to make up for the \$19.M. Pat Taylor said they have information for you to show how we would come up with this. Their concern is for the customers. Commissioner Carper said since the matter is mute, he is shocked that they wouldn't have taken the offer. Pat Taylor said when the board saw an immediate 40% increase these residents couldn't afford it and he didn't say it was a no. Commissioner Wheeler asked if the board would be inclined to look at an offer. Pat Taylor said absolutely, they have 1,650 customers to be concerned about. Commissioner Salango said that the Sissosnvile PSD informed the Commission in 2022 that they were near imminent failure, and since that day what upgrades have been made? Pat Taylor said none and they are still in danger of imminent failure. Commissioner Salango said that the PSD advised us in 2022 and we want to know now where you are coming up with \$19M because he does not see how this is possible. Angie Bailey, Officer Manager for the PSD, said they do have a project that is pending which costs \$1.9M and they do have a complete project for \$4.5M that is filed with the PSC. Commissioner Salango said that they do not need \$19M. Angie Bailey said that is not their project, theirs is \$1.9M.

Discussion regarding augmenting the salaries for the two Drug Court Case Managers

Commissioner W. Kent Carper Commission President Lance Wheeler Commissioner Ben Salango

Commissioner Carper said that he invited Judge Bailey to attend due to her being the one that started and currently runs Drug Court in Kanawha County. Judge Bailey said she and her staff thanked the Commission for the support of the Drug Court from the beginning. Commissioner Carper said there has been some discussion regarding the salary of the Drug Court Case managers and asked if she had an opinion on this. Judge Bailey said yes we have male and female coordinators who are in charge of the members of the program. They report daily, do drug screenings, and check with their employers. One of the present requirements is an associate degree but we do have a very high turnover due to the low salary. The salaries have not been raised since it started. Judge Bailey's suggestion is a salary increase of \$10,000 if possible. Commissioner Salango said that this program has been incredible since the Judge started this and now has 150 graduates, which affects hundreds of more family members. Babies are not born addicted to drugs and the Commission is very thankful for all of Judge Bailey's efforts and making sure drug court is a success stated Commissioner Salango. Commissioner Wheeler said that he did not know how emotional a drug court graduation would be until he attended one recently and this does help with the drug crisis. Commissioner Wheeler said he believes the opioid money the Commission received would be eligible for this program. At this time, the Commission will have staff look at the money and see if the money is there for the increases. Commissioner Wheeler said he believes the Commission should also look at Day Report and Home Confinement as well. Commissioner Carper said that he was not aware they could not fill the position and he thinks this needs to be looked at as soon as possible since they are trying to hire right now. Jenniferr Herrald said that staff will have a recommendation at the next Commission meeting.

Discussion regarding parking at the Judicial Building Commissioner W. Kent Carper Commission President Lance Wheeler Commissioner Ben Salango

Commissioner Carper said that he wanted this on record that the Supreme Court knows the County has to remodel the Judicial building and this means the County will not have public parking. We can't stretch the property. Commissioner Carper said that he is not criticizing but we need to make sure everyone understands this is what the State requires the County to do. Commissioner Wheeler said that the Legislature passed the bill, and we have to do it. Commissioner Wheeler said that he voted for the remodel, and he supports it and unfortunately, we lose public parking.

# Discussion regarding Opioid Settlement Funding Requests Commissioner W. Kent Carper Commission President Lance Wheeler Commissioner Ben Salango

Commissioner Carper said he had staff help him to see what other counties throughout the country spent money on. When you look to see what they spent this money on, it's a waste. Commissioner Carper said that his point is we need to do what we've always done and make it as transparent as possible. One county bought a transport van for the morgue. Jennifer Herrald said the money that Green County Tennessee used \$50,000 to fund a litter crew vehicle to drive inmates to pick up trash. One county is using it to supplement its budget, paying for insurance and pay raises. Commissioner Wheeler said this is why this commission created an application that will be public. Chris Settles stated that Commissioner Carper requested that he prepare a letter from Region 5 with WV First Foundation. Commissioner Carper said one thing that Region 5 wanted was open meetings. Chris Settles said we are asking for an update on what incentives they have taken to see if they changed the by-laws to follow the Open Meetings Act. The letter also mentions the lack of communication. We have not seen the minutes or agendas. There is no communication with them, and we have no idea how they plan to spend the funds. Commissioner Carper said the Commission should send this letter to our representative and they are earning \$1M a month in interest. Commissioner Carper said let us find out if we can incur interest on our funds. The letter should go to everyone in Region 5. Mayor Ingram said that he agrees with the Commission that there is abuse with the opioid money. Mayor Ingram is here to represent the Upper Kanawha Valley Mayors except Pratt and Marmet. These towns do not have enough money each to make a difference, for example his town received \$60,000. The Mayor wanted to share their idea perhaps we could pool our money and place a Day Report Center in the Kanawha Valley. Mayor Ingram said they could see if there is a need up there, but he is sure there is. Mayor Ingram said it could help people with opioid service and provide community outreach. We just wanted to add this to the discussion, and they will fill out an application to the Commission. Commissioner Wheeler said he is not making any promises, but the Commission worked with the municipalities, and he suggests that Mayor Ingram and the mayors work with Commission staff and see what can be done.

Discussion regarding Kanawha-Charleston Humane Association and damage to their building, to include but not be limited to assistance from the Kanawha County Commission

Bethany Hively informed the Commission that they had an eventful week with a U-Haul driving through the shelter fortunately all staff and animals are ok. They are waiting for the structural engineer to confirm what part they can use. Then they

can start moving forward with construction with the insurance company. Commissioner Wheeler asked where they were with the HVAC system. Ms. Hively said they have two quotes to repair two air conditioners, and one is to replace them. The insurance company only has an obligation to repair not replace. They are 20 years old and are not good enough to repair. Commissioner Wheeler said that when board President Brady Campbell notified him he sent Mike Moles to check on the systems. Mike Moles informed the Commission that they need to be replaced. Commissioner Wheeler said that Mr. Campbell said it was about a \$6,100 difference but they have other expenses correct. Ms. Hively said yes, we do. Commissioner Carper asked how is their loss of revenue. Ms. Hively said it hasn't been too impacted because Todd Judy Ford paid for all adoptions and they have been receiving donations from the community. Commissioner Carper asked how much coverage the U-Haul had. Ms. Hively said \$25,000. Commissioner Salango said he is inclined to give more than the \$6,100 because they do not know everything until the structural engineer gives the reports. Commissioner Carper moved to contribute \$15,000 with \$10,000 from Dog Fund and \$5,000 from County Manager Fund and to process as an emergency. Commissioner Salango seconded. Motion carried.

Discussion regarding Coonskin and Big Bend Projects related to flood damage and the execution of notice to proceed documents with Thaxton Construction

Jeff Hutchinson informed the Commission that after the contract is signed they can start construction on Big Ben and they think it will go fast, one month but he thinks that is not correct. They have to build some roads along the cart paths to do the work. The contractor said it would be about a month for the first one then start the second one and they could be done with the work within two months. Commissioner Wheeler asked if Parks posted any notices. Jeff Hutchinson yes just not with a firm date. Once we have the date it will be shared. Commissioner Wheeler said that a lot of people are understanding and still plan to utilize the course. Commissioner Wheeler said that he heard the Coonskin trail will be closed. Jeff Hutchinson said yes it will close down while they do the work. Commissioner Salango moved to proceed with the construction. Commissioner Carper seconded. Motion carried.
