Addendum # 1 is being issued to address the following:

1. The Bid Specifications dated February 6, 2024, are to be considered a part of this Addendum #1.
2. Clarification: Bid specifications require straight gas packs with a/c.
3. Test and balance TAB is not required.
4. The electrical for the heat strips does not need to be removed all the way back to the breaker boxes. Set new disconnects on the roof for each unit with proper over current protection per NEC.
5. **ALTERNATE #1:** Provide & install five (5) wi-fi thermostats with new thermostat wire from the new unit to the thermostats. If Alternate #1 is accepted, Chesapeake VFD is to be invoiced separately.
6. **ALTERNATE #2:** Size the new natural gas heat load to include the garage bay where the trucks are located.
7. The Kanawha County Commission reserves the right to reject any and/or all bids and to waive any informality in bidding. Once bids are opened, all documents become public record.
