Project Summary

Please provide a narrative overview or summary of your proposal, including but not limited to the following:

1. Brief description of the proposal *

Bridge to Hope Academy- WV's first recovery high school. Recovery high schools are secondary schools designed specifically for students in recovery from substance use disorder or co-occurring disorders. Although each school operates differently depending on available community resources and state standards, each recovery high school shares the following goals listed below.

2. Purpose and key anticipated outcomes*

- The primary purpose of a recovery high school is to educate and support students in recovery from substance use or co-occurring disorders;
- Meet state requirements for awarding a secondary school diploma, i.e. school offers credits leading to a state-recognized high school diploma, and student is not just getting tutored or completing work from another school while there;
- Intent that all students enrolled be in recovery and working a program of recovery from substance use or co-occurring disorders as determined by the student and the School;
- All students are working an abstinence-focused program of recovery as agreed upon by the student and the school.

The staff of recovery high schools most often includes administrative staff, teachers, substance misuse counselors, and mental health professionals that each play a critical role in supporting their students. Additionally, recovery high schools provide support for families learning to how to live with, and provide support for, their teens entering into the recovery lifestyle.

There are 45 recovery high schools throughout the United States. This will be the first in WV.

High school students grades 9-12 who are in recovery from substance use disorder and or mental health. Initially it will be open to Kanawha and Putnam counties with the hopes of expanding statewide once it is established.

8. How Opioid Settlement funds, if awarded, will be used*

Bridge to Hope Academy (Recovery High School) will use the Opioid Settlement funds to hire a director and learning coach to operate the recovery high school. This includes recruiting students and securing additional funding to sustain all aspects of the school. The target launch of the school is Fall 2024 pending funding as a microschool. Community partners have committed to provide all of the wrap around services to the students and their families. These include all of the individual and group therapies, peer recovery support services and life skill training. This will be a microschool. Microschooling is the reinvention of the one-room school house, where class size is typically smaller than that in most schools and there are mixed-age level groupings. Generally, microschools do not meet all 5 days of the school week, and their schedules look different than a traditional public or private school. Wikipedia Focus is on student's recovery in conjunction with academics.

It will be ongoing and tentative opening of the school is fall of 2024.

Proposal Details

1. Please describe the problem or need which your project seeks to address*

Based on the data from the WV Office of Drug Control Data Dashboard*, there are hundreds of suspected overdoses in the under 18 years of age group annually. These include EMS Suspected Overdoses and ER Suspected Overdoses. Currently, there are no recovery high schools in WV that provide support to this age group once they have gone through treatment and are now in recovery. Most often the students return to the environment where they were in active addiction. This includes returning to their high school. Without proper support, they are at a much higher risk to relapse and not remain in recovery.

There are 45 recovery high schools throughout the United States. This will be the first in WV. In a recovery high school, students can complete an individualized course of study, move forward graduation and reduce risk of drug use and relapse. Teens who are struggling with drug and alcohol misuse may benefit from attending a recovery high school. In such an educational setting, teens can complete their coursework while also receiving the support they need to continue healing and recovery.

Our mission Community Bridge's mission is to foster community partnerships and collaborations among churches, businesses, hospitals, schools, nonprofits, foster networks, and the sober living community to provide items to meet basic physiologic needs and offer life skills education for low-income households, homeless individuals, foster families, and those with substance use disorders living in West Virginia, to improve their mental and physical health all while showing the love of Christ.

Community Bridge serves our community through our Community Bridge Resource Center, addiction recovery classes and various outreaches. The Resource Center provides free items such as clothing, furniture, household items and hygiene products to families and individuals in need. Community Bridge Recovery offers a twelve step program and support group to help those seeking freedom from addictions of all types. The Bridge to Hope Academy, a recovery high school, will also be housed in the Community Bridge Family Life Center. Community Bridge holds a variety of outreach events throughout the year to help our community in various ways such as cooking classes, Bless You Day, and Self Care Fairs. On Bless You Day, a semi-annual event, an average of 700 people will attend and take home a variety of free items, speak with representatives from community organizations that offer assistance of all types, and partake in a free lunch. 


